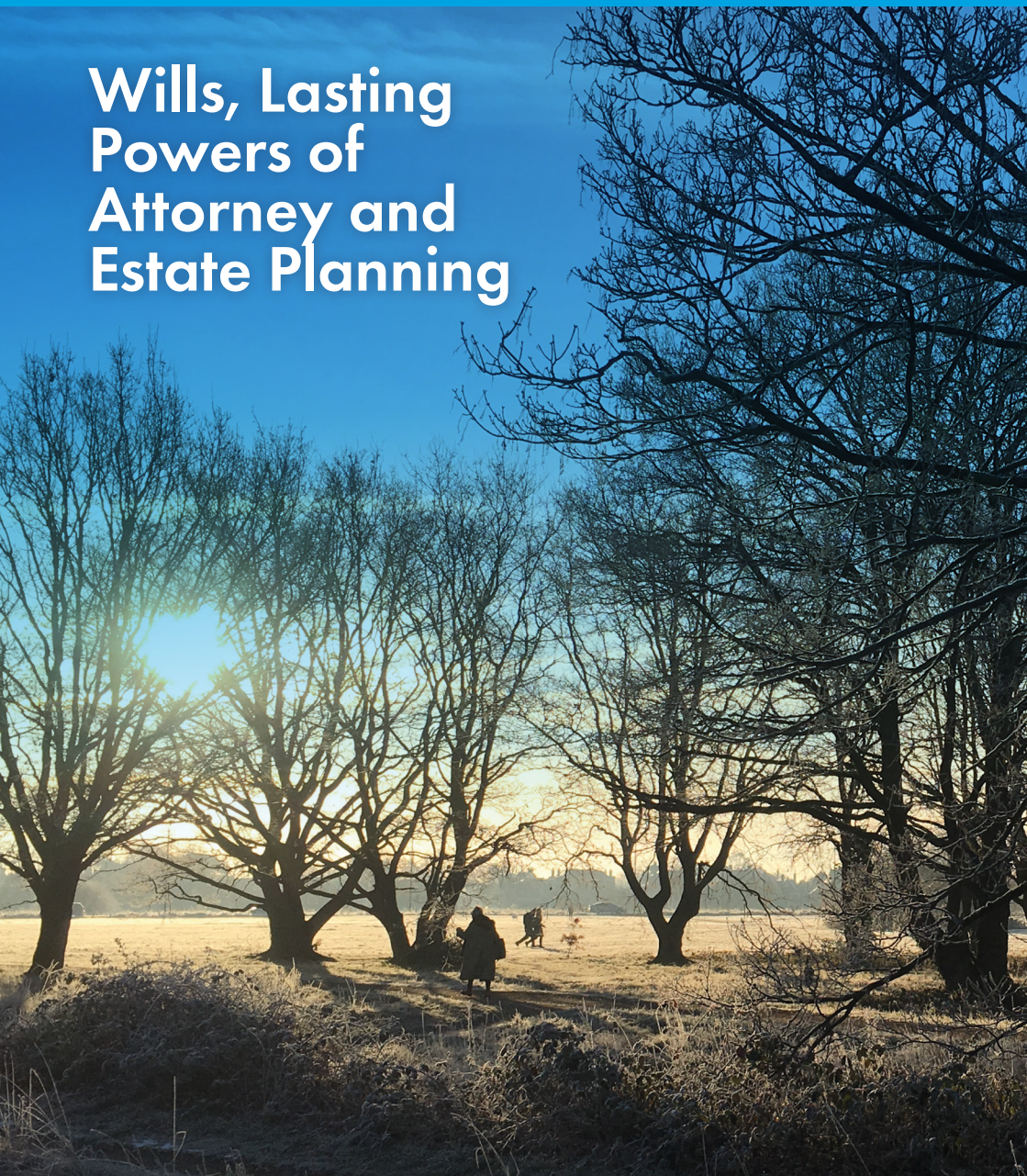

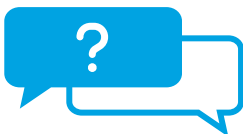

Wills

Creating a will is one of the simplest, yet most impactful steps you can take to protect your loved ones and ensure your wishes are followed.

Without a will, the law decides how your estate is distributed, which might not align with your wishes – for example, your spouse might not automatically inherit everything and unmarried partners have no automatic rights.

DIY wills often fail to account for complexities and it is easy to fall foul of the strict signing rules, leading to potential disputes or an invalid will. A professionally drafted will ensures clarity and security for you and your loved ones. For peace of mind, we can store your will safely, without charge, and register it with The National Wills Register.

By drawing up a will, you can:

- ✓ Choose whom benefits in your will
- ✓ Plan for inheritance tax
- ✓ Decide at what age minors will inherit
- ✓ Put trusts in place for minors or vulnerable beneficiaries or to protect any means tested benefits
- ✓ Appoint guardians for minors
- ✓ Include funeral wishes
- ✓ In the case of a second marriage, to use will trusts to provide for your spouse, but ensure your estate is ultimately protected for your children.



Lasting Powers of Attorney

Whilst a will assists after you die, a Lasting Power of Attorney (LPA) allows you to appoint someone to make decisions on your behalf during your lifetime, should you be unable to do so, at any point in the future. There are two separate LPAs:

- ✓ LPA for property and financial affairs.
- ✓ LPA for health and welfare decisions.



You can choose attorneys to act on your behalf and decide how they will make their decisions. You can also appoint replacement attorneys in case your chosen attorneys cannot act for any reason. You can put guidance and restrictions into the LPA although we advise keeping it as flexible as possible.

It is important to have your LPA registered. Without an LPA in place, if you lose mental capacity, your loved ones might face a lengthy and costly court process to manage your financial affairs. Medical decisions could be made without your input, potentially going against your wishes.

Trusts and Inheritance Tax Planning

Estate planning becomes more meaningful when you think inter-generationally and this is where inheritance tax planning comes in – a step (to protect your assets) beyond just making a will. Our goal is to provide you with peace of mind that you are doing all you can to safeguard your hard-earned assets for generations to come.

We can advise on how to pass assets down to the next generation as well as give guidance to beneficiaries on how to use inherited assets wisely.



Trusts are used for many purposes, including making gifts to beneficiaries that are minors or vulnerable and, as with a gift, they can fall outside of your estate after a period of time. Setting up a trust is a worthwhile but complex process and should only be done after taking specialist advice. We can advise you on the right trust for your circumstances and on the tax consequences of any trust you set up.
